Competitive e-tenders are invited in TWO COVER bid system through [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) from reputed manufacturers for the supply and commissioning of dismantling type DTH rig capable of drilling bore wells up to 100m away from truck, of size 110 to 127 mm dia bores in hard rock formation and 178mm dia bores in over burden, up to a total depth of 150m and compressor working at 200 psi 600 cfm, mounted separately on two Trucks as specified separately.

The technical bid should contain the following documents

1. Pre-qualification criteria

- a. The bidder should furnish the information on past supplies from at least two govt/quasi government institutions in India and satisfactory performance certificate from end user.
- b. The bidder shall furnish data to support that he has the financial and production capacity to perform the contract and complete the supplies within the stipulated delivery period
- c. Proof regarding the bidder should be in continuous business of manufacturing and after sale services of dismantling type DTH rigs during the last 5 years prior to bid opening year.

- d. The Bidder should furnish a brief write-up, backed with adequate data, explaining his available capacity and experience (both technical and commercial) for the manufacture and supply of the Dismantling type DTH rigs within the specified time of completion after meeting all their current commitments.
  - e. The bidder should clearly confirm that all the facilities exist in his factory for inspection and testing and these will be made available to the purchaser or his representative for inspection.
  - f. Proof of annual turnover of atleast Rs. 450 lakhs per annum for the last three years
2. Detailed Technical Specification along with List of accessories with Name, Make and Model of the quoted machinery and its accessories
  3. Original brochures & literature supporting the technical specification.
  4. Agreement in Kerala Stamp Paper worth Rs.200/-. The original agreement should reach in the Directorate of Ground Water Department, Thiruvananthapuram, Kerala after tender closing date (21-08-2019 4.00 PM) and before the tender opening date (24-08-2019 11.00 AM).
  5. Reports on Financial standing of the bidders such as profit and loss statements, balance sheets and auditor's report for the past three years
  6. Documents on legal status, place of registration and principal place of business of the company or firm or partnership etc.
  7. Copy of GST registration certificate
  8. Acceptance of terms and conditions, Date up to which the rates are firm

Financial bid (BOQ) should contain the following

1. Total cost of the machinery inclusive of all taxes, duties, transportation cost and loading /unloading charges in BOQ1
2. Individual rates of the following also shall be quoted separately in BOQ2 for information purpose

- a) Truck
- b) Compressor
- c) Rotation Motor
- d) Winch Motor
- e) Drill Rod
- f) Hammer
- g) Overburden Button Bits
- h) 127 mm dia Button Bits
- i) Drag/Mud Bits
- j) Wire Braided Air hose

Financial bid of technically qualified bidders will be opened. Financial evaluation of the bids will be carried out based on the rate quoted in BOQ1, for the rig as a whole unit. The rates quoted in BOQ2 for individual items are for information purpose only. The supply order will be placed for rig as a whole unit, not for individual items.

The tender should be submitted only through online system. Any other type of tenders will not be accepted. The technical documents are to be uploaded in .pdf and financial bid (BOQ) in .xls form. The hard copy of the tender documents will not be accepted except the agreement in Kerala stamp paper worth Rs.200/-.

All Government rules prevailing will be applicable to the tender. Director of Ground Water Department, Thiruvananthapuram, Kerala reserves the right to cancel, accept or reject all or any tender at his sole discretion without assigning any reason. For legal purposes, the cause of action will be deemed to have arisen in Trivandrum, Kerala State, India.
