As per reference 1<sup>st</sup> cited, Smt. Manjumol.K.K, Junior Hydrogeologist has submitted duly filled application for declaring probation in the cadre of Junior Hydrogeologist. As per reference 3<sup>rd</sup> cited, Smt. Manjumol.K.K was appointed as Junior Hydrogeologist and she had joined duty on 09/09/2013. As per reference 4<sup>th</sup> cited, the Accountant General has informed that the incumbent has availed miscarriage leave for 42 days with effect from 28/02/14 to 10/04/2014, prefix 27/02/14, Commuted leave for 3 days with effect from 05/09/2018 to 07/09/2018 & Miscarriage leave for 42 days with effect from 10/09/2018 to 21/10/2018 which counts as non qualifying service during the period from 09/09/2013 to 24/09/2019.

Smt. Manjumol.K.K has passed the Account Test for Executive Officers conducted by Kerala Public Service Commission on 27/04/2019 ( Certificate ID: 97146#1#8 ) There is no vigilance case / Departmental proceedings initiated against the incumbent during the probation period. The probation period is two years service with in a continuous period of three years. As she had passed the Account test only on 27/04/2019. Her probation period has been extended from 09/09/2015 to 08/09/2016 by the Director, Groundwater Department, Thiruvananthapuram vide paper read 5<sup>th</sup> above. Government vide paper 6<sup>th</sup> above extended her probation period and sanction is accorded to declare her probation with effect from 28/04/2019 FN.
