ORDER

Sri. C.T. Rajesh , Superintending Engineer (General), who was also in charge of Superintending Engineer (HP) has been continuing on leave since 01/11/2019. Earlier Smt. Rini Rani, Senior most Executive Engineer (General) was given charge of both Superintending Engineer (HP) and Superintending Engineer (General) as per order read as 1st above.

Vide G.O read as 2nd paper. Sri. T K Premlal, District Officer, Groundwater Department, Thrissur, was transferred to Headquarters and posted as Executive Engineer in the vacancy that arose due to the transfer of Smt. Rini Rani. On his request Sri. T.K Premlal, Senior most Executive Engineer was given the charge of Superintending Engineer (General) and Superintending Engineer (HP) vide order read as 3rd paper.

Government vide Order read as 4th above, ratified the action of the Director in having given the charge of Superintending Engineer (General) and Superintending Engineer (HP) to Smt. Rini Rani and also directed that the charge of Superintending Engineer (HP) should be handed over to Executive Engineer (H) with immediate effect.

As per Government Order read as 5th above Government had promoted Sri. T K Premlal, Executive Engineer as Superintending Engineer (General) and Sri. C T Rajesh was posted as Superintending Engineer (HP). Since Sri. C T Rajesh was on leave, proceedings read as 6th paper was issued, in compliance of the Government Order cited 4th and Sri. Shajatan K H, Executive Engineer (H) was given the charge of Superintending Engineer (HP) subject to Government ratification.

As per letter read as 7th paper, Government informed that since as per Government Order 5th cited Sri. T.K. Premlal was promoted as Superintending Engineer and posted as Superintending Engineer (General) vice Sri. C. T. Rajesh, who was transferred and posted as Superintending Engineer (HP), the handing over of additional charge of Superintending Engineer (HP) to Executive Engineer (H) ordered in the Government Order read as 4th does not exist. Sri. C. T Rajesh, Superintending Engineer (HP) who is on long leave has also applied for Voluntary Retirement from Service with effect from the AN of 30/04/2020.

In the above circumstances it would be highly beneficial if the charge of Superintending Engineer (HP) be handed over to Sri. T K Premlal, Superintending Engineer (General), who with his experience in handling the project over the years could boost the performance of the department to acheive the stipulated targets within the specified time limits. Also, for conduct of procurements under National Hydrology Project through e-tender, there is a need of a Superintending Engineer experienced in procurement and owning a digital signature. As such it is hereby ordered that the charge of Superintending Engineer (HP) is given to Sri. T K Premlal, Superintending Engineer (General) subject to Government ratification. Sri. Shajatnan K H, Executive Engineer (H) who is currently holding the charge of Superintending Engineer (HP) shall immediately hand over the same to Sri. T. K Premlal, Superintending Engineer (General).
