**ORDER**

As per the order read 1<sup>st</sup> paper, sanction was accorded to the District Officer, Ground Water Department, Idukki for implementation of mini water supply scheme at Pachadibhagom in Nedunkandom Grama Panchayat in Idukki District for an amount of Rs. 6,55,000/-


As per the letter read as 2<sup>nd</sup> paper, District Officer, Ground Water Department, Idukki has reported that Mini Water Supply Scheme has been implemented at Pachadibhagom in Nedunkandom Grama Panchayat in Idukki District. Final bill comes to Rs. 7,18,288/-. This is because the earth work GI pipe laying exceeded than the estimate. District Officer has also requested to issue revised sanction for the above work.

As per the order read as 3<sup>rd</sup> paper, Director, Groundwater Department has accorded revised administrative sanction for the implementation of mini water supply scheme at Pachadibhagom in Nedunkandom Grama Panchayat in Idukki District.

In the above circumstances and after examining the matter in detail, revised technical sanction is hereby accorded to District Officer, Ground Water Department, Idukki District for an amount of Rs.7,18,288/- (Rupees Seven lakhs eighteen thousand two hundred and eighty eight only) for meeting the expenditure for the mini water supply scheme at Pachadibhagom in Nedunkandom Grama Panchayat in Idukki District under Ground Water Based Drinking Water Supply Scheme.

The District Officer should ensure that the work is carried out as per Government rules and that the scheme satisfies all the norms and conditions of Ground Water Based Drinking Water Supply Scheme. The scheme after completion should be handed over to the beneficiary committee. The beneficiary committee should run and carry out further maintenance of the scheme and meet all expenditure for the purpose. District Officer should also make sure that the payment is made only as per the actual quantity and measurement of each item.

The expenditure in this regard can be met from the fund available under the Head of account "4702-00-102-94 scheme for Ground Water Based Drinking Water Scheme" for the financial year 2021-2022.
