
Vide read cited 1<sup>st</sup> above, District Officer, Ground Water Department, Thiruvananthapuram has forwarded, a proposal for the Construction of borewell & implementation of MWSS and its allied work at Aaram Kuzhivila, Pallickal Grama Panchayath in Thiruvananthapuram District for an estimated amount of Rs. 5,93,000/- ( Rupees Five lakhs and ninety three thousand only) and requested for the sanction of the construction of bore well and implementation of scheme under Jala Jeevan Mission.

Vide reference 2<sup>nd</sup> cited above, Government have accorded administrative sanction for implementation of Mini Water Supply Scheme and its allied work at above mentioned site.

After detailed verification, estimate amount proposed by the District Officer is found correct ie. Rs. 5,93,000/- ( Rupees Five lakhs and ninety three thousand only).

In the above circumstances, technical sanction is hereby accorded to District Officer, Ground Water Department, Thiruvananthapuram for the construction of borewell and implementation of MWSS and its allied work at Aaram Kuzhivila, Pallickal Grama Panchayath in Thiruvananthapuram District for an amount of Rs. 5,93,000/- ( Rupees Five lakhs and ninety three thousand only).


