The District Officer should forward detailed estimate for Water Supply Scheme as per the yield after construction of bore well.

The expenditure in this regard can be met from the fund available under the Head of account "4702-00-102-94 - (01) Ground Water Based Drinking Water Scheme (P)" for the financial year 2022-2023.
