ORDER

As per the letter read, the District Officer, Ground Water Department, Kasaragod has forwarded a proposal for the construction of bore well at Padiyathadukka in Karadka Grama Panchayath in Kasaragod District for an estimated amount of Rs. 92,382/- (Rupees Ninety two thousand three hundred eighty two only) and requested for the sanction under Ground Water Based Drinking Water Supply Scheme.


The proposal for the construction of bore well, submitted by the District Officer has been verified and the amount is limited to Rs. 86,502/- (Rupees Eighty six thousand five hundred and two only).

As per the order read as 2nd paper Administrative sanction for an amount of Rs. 86,502/- (Rupees Eighty six thousand five hundred and two only)) has been accorded by the Director of Groundwater Department for the above work.

After examining the matter in detail, Technical sanction is hereby accorded to the District Officer, Ground Water Department, Kasaragod for the construction of bore well at Padiyathadukka in Karadka Grama Panchayath in Kasaragod District for an amount of Rs. 86,502/- (Rupees Eighty six thousand five hundred and two only).

The District Officer, Ground Water Department, Kasaragod should ensure that the work should be carried out as per Government rules and that the scheme satisfies all the norms and conditions of Ground Water Based Drinking Water Supply Scheme. The work should be supervised by the technical staff of the Department. The District Officer should also make sure that the payment is made only as per the actual quantity and measurement of each item. The District Officer should forward detailed estimate for Water Supply Scheme as per the yield after construction of bore well.

The expenditure in this regard can be met from the budget provision of Rs. 400 lakhs under the Head of account "4702-00-102-94-01-scheme for Ground Water Based Drinking Water Scheme (P)" for the financial year 2022-2023. The date of completion of the scheme is to be intimated before the end of the financial year 2022-23.
