**ORDER**

As per the letter read, the District Officer, Ground Water Department, Pathanamthitta has forwarded a proposal for the construction of bore well at Kadapra Tholumkara and Vavottadam para in Koipuram Grama Panchayath in Pathanamthitta District for an estimated amount of Rs. 1,28,654/- (Rupees One lakh twenty eight thousand six hundred and fifty four only ) and requested for the sanction under Ground Water Based Drinking Water Supply Scheme.

The proposal for the construction of bore well, submitted by the District Officer has been verified and the amount is limited to Rs. 1,27,554/- (Rupees One lakh twenty seven thousand five hundred and fifty four only ).

As per the order read as 2<sup>nd</sup> paper Administrative sanction for an amount of Rs. 1,27,554/- (Rupees One lakh twenty seven thousand five hundred and fifty four only )has been accorded by the Director of Groundwater Department.


After examining the matter in detail, Technical sanction is hereby accorded to the District Officer, Ground Water Department, Pathanamthitta for the construction of bore

well at Kadapra Tholumkara and Vavottadam para in Koipuram Grama Panchayath in Pathanamthitta District for an amount of Rs. 1,27,554/- (Rupees One lakh twenty seven thousand five hundred and fifty four only ) as detailed below:-

1. Kadapra Tholumkara, Koipuram Grama Panchayath	- Rs. 63,498/-
2. Vavottadam para, Koipuram Grama Panchayath	- <u>Rs. 64,056/-</u>
Total	- <u>Rs. 1,27,554/-</u>

The District Officer, Ground Water Department, Pathanamthitta should ensure that the work should be carried out as per Government rules and that the scheme satisfies all the norms and conditions of Ground Water Based Drinking Water Supply Scheme. The work should be supervised by the technical staff of the Department. The District Officer should also make sure that the payment is made only as per the actual quantity and measurement of each item. The District Officer should forward detailed estimate for Water Supply Scheme as per the yield after construction of bore well.

The expenditure in this regard can be met from the fund available under the Budget provision of Rs. 400 lakhs under the Head of account "4702-00-102-94 Plan" scheme for Ground Water Based Drinking Water Scheme for the financial year 2022-2023. The District Officer should intimate the date of completion of the scheme.

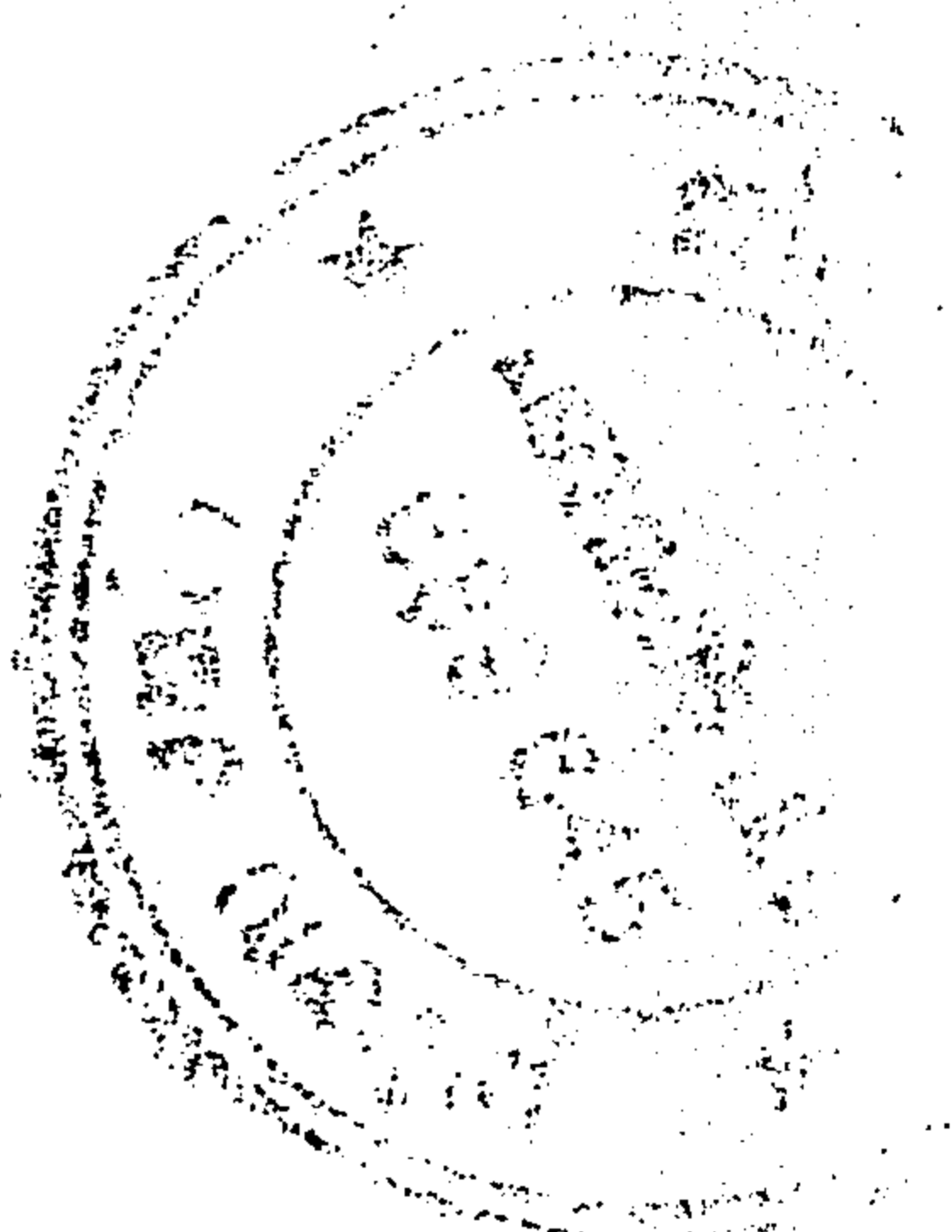

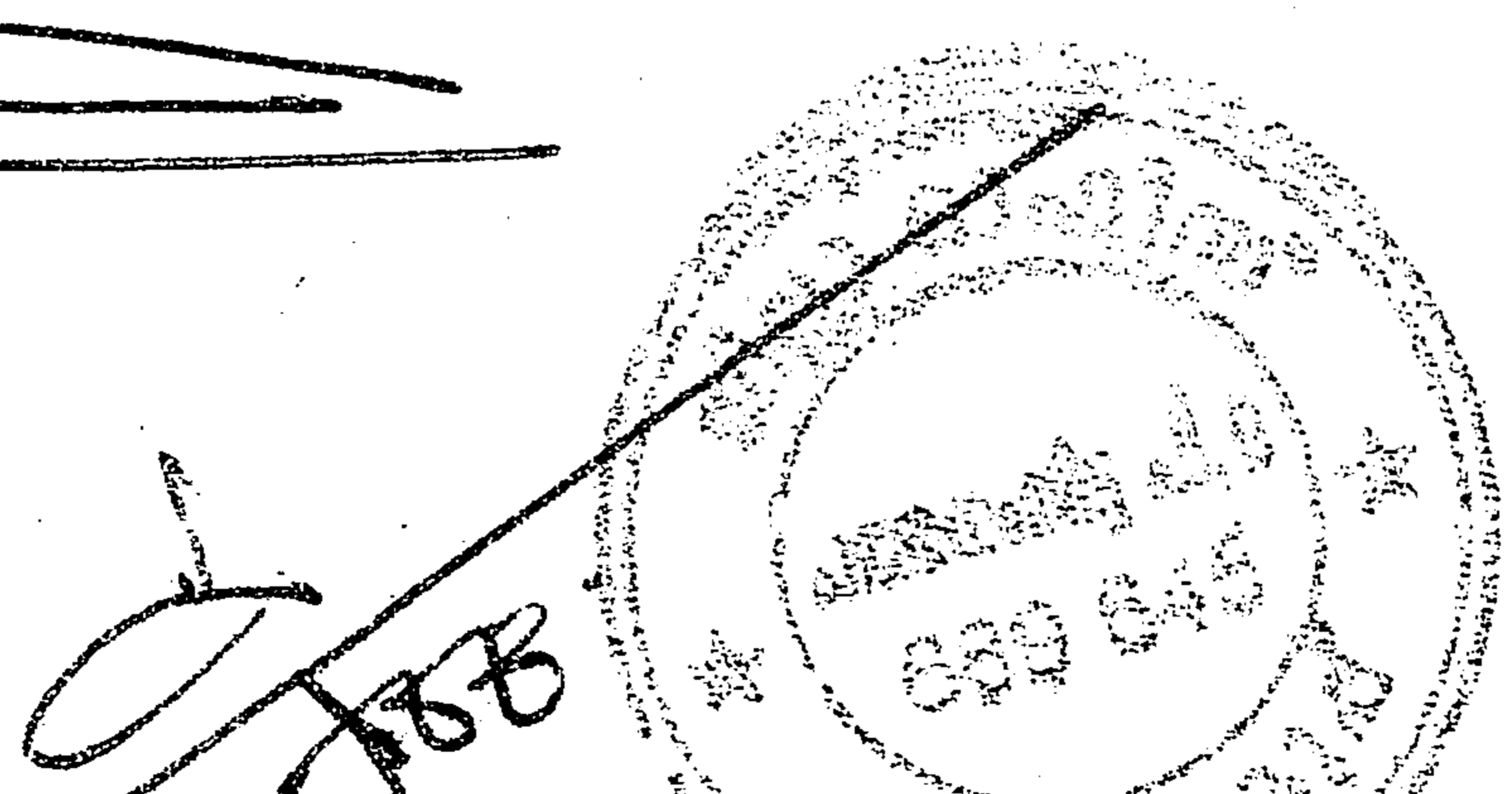
