ORDER

Vide reference cited above, District Officer, Ground Water Department, Thrissur has forwarded a proposal for the implementation of Groundwater Conservation and Recharge Schemes (Direct Dug well recharge – 1No.) at Sports Council Complex in Thrissur District for an estimated amount of Rs. 3,70,000/- (Rupees Three lakhs and seventy thousand only) under the scheme for Groundwater Conservation and Recharge.

As per the order read as 2nd paper above, Administrative Sanction for an amount of Rs. 2,20,000/- (Rupees Two lakhs and twenty thousand only) has been accorded by the Director of Ground Water Department under the scheme for Groundwater Conservation and Recharge including 12% GST.

After examining the matter in detail, revised Administrative sanction is hereby accorded to the District Officer, Ground Water Department, Thrissur for the implementation of Groundwater Conservation and Recharge Schemes (Direct Dug well recharge – 1No.) at Sports Council Complex in Thrissur District for a total cost of Rs. 2,35,000/- (Rupees Two lakhs and thirty five thousand only) under Groundwater Conservation and Recharge scheme including 18% GST amount of Rs. 35848/-.

The District Officer, Ground Water Department, Thrisur should ensure that the work should be carried out as per the Government norms and rules and completion report should be furnished along with the as built drawing to the undersigned. The payment shall be effected only for the actual quantity implemented as per the approved rates to each items. The District Officer should obtain consent from the concerned competent authorities before the commencement of the work. The work should be completed within the financial year of 2022-2023.

The expenditure can be met from the fund available under the Head of account "4702-00-102-97 (Plan) Scheme for Groundwater Conservation and Recharge for the financial year 2022-23.
