ORDER

As per the letter read 1st, District Officer, Groundwater Department, Thiruvananthapuram has forwarded a proposal with detailed estimate for an amount of Rs. 1,29,000/- (Rupees One lakh and twenty nine thousand only) for the renovation of Mini Water Supply Scheme at Ayiravalli, Plachivila Ward in Pallickal Grama Panchayath in Thiruvananthapuram District under Ground Water Based Drinking Water Scheme for the year 2022–23.

The proposal for the renovation of Mini Water Supply Scheme submitted by the District Officer has been verified and the amount is limited to Rs. 1,28,000/- (Rupees One lakh and twenty eight thousand only).

As per the order read as 2nd paper Administrative Sanction for an amount of Rs. 1,28,000/- (Rupees One lakh and twenty eight thousand only) has been accorded by the Director of Ground Water Department for the above work.

After examining the matter in detail, Technical sanction is hereby accorded to the District Officer, Ground Water Department, Thiruvananthapuram for an amount Rs. 1,28,000/- (Rupees One lakh and twenty eight thousand only) for the renovation of Mini Water Supply Scheme at Ayiravalli, Plachivila Ward in Pallickal Grama Panchayath in Thiruvananthapuram District under Ground Water Based Drinking Water Scheme. Here Estimated amount is Rs. 1,09,678/- and 18% GST amount is Rs. 18,322/-.

The District Officer should ensure that the work is carried out as per Government rules and that the scheme satisfies all the norms and conditions of Ground Water Based Drinking Water Supply Scheme. The work should be supervised by the technical staff of the department. The scheme after completion should be handed over to the beneficiary committee. The beneficiary committee should run and carry out further maintenance of the scheme and meet all expenditure for the purpose. District Officer should also make sure that the payment is made only as per the actual quantity and measurement of each item.

The expenditure in this regard can be met from the budget provision of Rs. 158 lakhs under the head of account "2702-02-103-99 scheme for Ground Water Based Drinking Water Scheme (P)" for the financial year 2022-2023.
